## SPECIFICATIONS

### SITE PREPARATION/WEED SUPPRESSION PROJECT

#### BUREAU OF STATE PARKS BIG ELK CREEK STATE PARK CHESTER COUNTY

##### SCOPE OF WORK:

The Department of Conservation and Natural Resources (DCNR), Bureau of State Parks, Big Elk Creek State Park requires **chemical herbicide application services** to suppress invasive annual and perennial weeds in previously cultivated fields in preparation for pollinator habitat planting. The treatment recommendations were developed to suppress annual and perennial weeds in a former crop field and two small former pasture areas to reduce competition during establishment of desirable native warm season grasses and native forbs. The services shall include, but are not limited to, the furnishing of all materials, herbicides, laborer, superintendence, tools, and equipment required for the ground application of herbicides as per the following specifications.

##### PROJECT LOCATION AND CHARACTERISTICS:

The work area consists of:

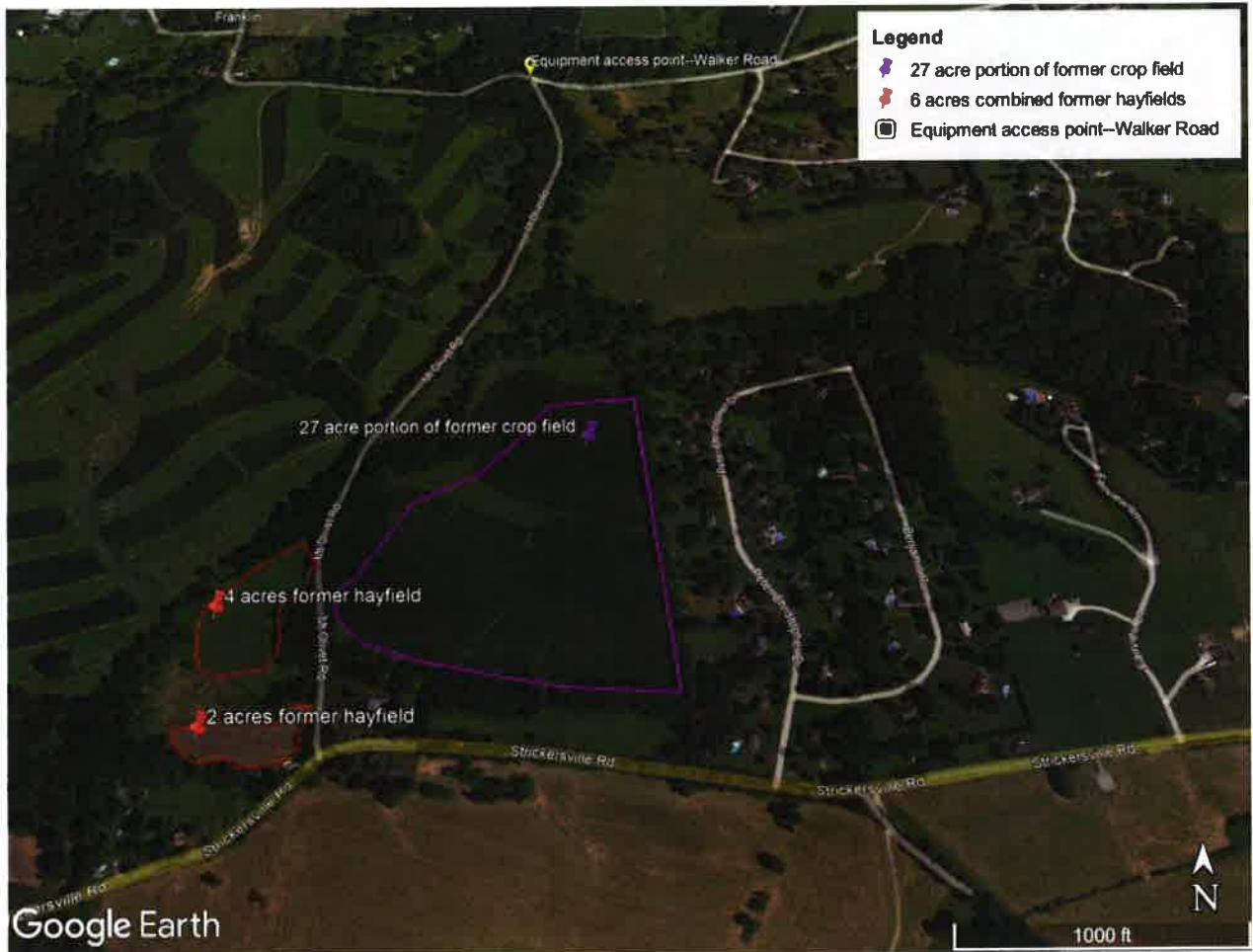
One 27-acre block on the east side of a tributary to Big Elk Creek near Mount Olivet Trail (a decommissioned road). The field is adjacent to the trail between Walker Road and Stricklersville Road in Big Elk Creek State Park, Franklin Township, Chester County. The site must be accessed from the trail, which is the former Mount Olivet Road. Equipment must enter the trail via the Walker Road entrance. There is a weight limitation of 10 tons on this trail. The block is about 26 acres of cornfield harvested in fall 2022, and about an acre of grass.

Two small former hayfields separated by a wetland area. The total pasture area to be treated is about 6 acres. One section is about 4 acres and the other is about 2 acres. These pastures are on the opposite side of Mount Olivet Trail from the cornfield. It may be possible for equipment to access one or both of these former hayfields from the Stricklersville Road entrance to the trail.

All work will be performed in terrestrial upland areas; however, due to the sensitive nature of nearby habitats, all herbicide formulations and adjuvants must be labeled for use in aquatic and terrestrial sites. See. ACCEPTABLE HERBICIDE FORMULATIONS AND DELIVERY METHODS below.

Contractor should provide a quote breaking down cost of each of the two work items (#1, 27-acre cornfield; #2, 6 acres of hayfield). DCNR Field Service Specialist will decide whether to include both items or only item #1 before a final agreement is made. Payment will be made only for work items actually performed.

**D. CONTRACTOR QUALIFICATIONS:**

Prospective contractor must be a currently Licensed Pesticide Applicator with the Commonwealth at the time of quote in categories appropriate for ground spraying in Pennsylvania State Parks, and the prospective contractor must have an office(s), maintenance facilities, equipment, employees, and qualified equipment operators and mechanics, and have tools, equipment, and spare parts for the make and type of equipment indicated in these specifications.

**E. CONTRACT ADMINISTRATIVE REQUIREMENTS:**

All contracts must be completed by the termination date. The Bureau of State Parks reserves the right to evaluate the proposed spray operation, including but not limited to equipment operators, spray equipment and operating plan, and reject any part of the operation that, in the Bureau of State Parks' opinion, will result in unsatisfactory performance.

**GENERAL CONTRACT TASKS:**

1. **PURPOSE** - The purpose and intent of this document is to provide specifications for herbicide(s), equipment, application, and other operational requirements necessary for a properly prepared and executed contract and for securing proper equipment, dispersal systems, service facilities, qualified ground personnel, and qualified equipment operators capable of making a proper application of herbicide and performing necessary related functions.
2. **ACREAGE** - The Bureau of State Parks requires treatment for 27 acres of former crop field and 6 acres of former hayfield at Big Elk Creek State Park. The treatment areas are being converted to wildlife/pollinator habitat.
3. **SPECIES TO BE CONTROLLED** – Ground application of glyphosate-based herbicide on 27 acres of former crop field and 6 acres of former hayfield. Control all emerging annual and perennial plants, in preparation for native warm-season grass and forb seeding.

**RECALL** - The contractor may be recalled to treat any area(s) that were missed or to retreat area(s) because of faulty application, wash-off, or inadequate herbicide effectiveness. The Bureau of State Parks will resolve any disputes between the contractor and the Bureau of State Parks. Recall spraying and respraying resulting from misses and faulty application will be at the contractor's expense. The contractor will be required to treat, without any additional compensation, areas not treated due to skips, faulty application or equipment limitations that were not immediately apparent after initial application. The park manager or field service specialist will make this decision up to six (6) weeks after completion of a spray block and will transmit a final written decision to the contractor with the exact locations and time frames of the areas that must be retreated. Thereafter, the contractor will be required to complete the retreatment by the date specified in the park manager's letter.

- 4. DAMAGE TO COMMONWEALTH PROPERTY** - The contractor shall be responsible for any damage to Commonwealth property resulting from the improper use of equipment for this spray operation. The contractor will be given one (1) written warning that damage is becoming excessive and if the action continues damages will be assessed.

**State Park Facilities** - Contractor shall immediately repair in a manner which meets with the approval of the Park Manager, any damage to State Park roads and/or other facilities, including access roads, resulting from the contractor's use for this spray operation. General wear and tear are accepted. The Park Manager may notify the contractor in writing to temporarily discontinue use of any of the above whenever in their opinion such action is necessary to prevent serious damage.

#### **INDIVIDUAL CONTRACT SPECIFICATIONS:**

1. County/Townships Involved: Chester County, Franklin Township
2. State Park: Big Elk Creek State Park
3. Type of Treatment: Broadcast non-residual herbicide treatments
4. Total Anticipated Acres: 33 acres (27 acres former crop field and 6 acres former hay field)
5. Estimated Starting Date: Following contract approval.
6. Estimated Ending Date: May 12, 2023.

#### **OBLIGATIONS OF THE CONTRACTOR:**

1. **GENERAL** - The contractor is obligated to furnish spray equipment, spray materials, support equipment, and personnel necessary to produce an herbicide application in accordance with the contract specifications. Other sections in these contract specifications give more specific information on the equipment and personnel required. **The contractor maintains responsibility for an entire contract even if another organization is providing part of the equipment and personnel.**

**PESTICIDE APPLICATION BUSINESS LICENSE** - The contractor must show proof of a valid Pesticide Application Business License issued by the Pennsylvania Department of Agriculture (PDA) in a category appropriate for ground spraying of state parks. Proof of Pesticide Applicator License must be furnished at the time the contractor provides the quote.

**PROOF OF INSURANCE** - The contractor must provide proof of insurance as specified for equipment owned, leased, rented, subcontracted, or otherwise utilized by the contractor and for all personnel hired, subcontracted, or otherwise employed by the contractor per requirements in Section J.

4. **SPRAY MATERIALS** - The contractor is responsible for the purchase of the herbicide and any dilutants used in this project. Specific details on herbicides and dilutants are given in Section I.
5. **START DATE** - The contractor must notify the Park Manager three (3) days prior to the beginning of application.

6. **MAINTENANCE** - The contractor must maintain a readily available on-site inventory of commonly needed spare parts and spare equipment including, but not limited to, pumps, pump seals, and other components to provide current maintenance on the spray system and equipment, the mixing and pumping system, the support trucks, and the storage tanks and to provide for immediate replacement of critically needed parts and equipment. Routine maintenance must be conducted only at times that will not interfere with the spray operation. Care shall always be taken to prevent leakage of spray material.
7. **SECURITY** - Guard service for the spray equipment and/or support equipment is the responsibility of the contractor.
8. **FIELD EXPENSES AND TRANSPORTATION** - Costs incurred in the operation and maintenance of all contractor equipment are the responsibility of the contractor.
9. **SPILL CLEANUP EXPENSES** - The contractor is responsible for all cleanup activity and costs resulting from any contamination caused by the accidental or intentional spilling, leakage, or dumping of herbicide, fuel, oil, or any other contaminant from contractor supplied equipment.
10. **SAFETY** - The contractor is required to conduct all operations in a safe manner. The contractor must provide essential safety equipment including, but not limited to, properly sized and coded fire extinguishers and spill-containment materials and supplies.

#### **HERBICIDES AND ADJUVANTS:**

1. **PURCHASING, STORAGE, AND TRANSPORTATION** - The contractor must purchase the herbicide used on this project, pay all applicable sales and use taxes, and arrange for delivery of the product to a suitable site where it will be secure and protected from damage. The contractor must assure that adequate supplies of herbicide are strategically located in the contract area to assure an efficient operation. The contractor must also assure that its personnel and Bureau of State Parks personnel are aware of the locations of these supplies.

The contractor is responsible for handling and transporting the herbicide from the storage site to the treatment area.

2. **MSDS** - The contractor must keep a copy of the Safety Data Sheets (SDS) available on site throughout the course of the project for any herbicide or other materials requiring an SDS which are supplied by the manufacturer for the project.

3. **ACCEPTABLE HERBICIDE FORMULATIONS AND DELIVERY METHODS** - All spraying will be conducted with the acceptable formulations and delivery methods identified below. Contractor must follow all label restrictions regarding use near perennial standing water or streams.

**Ground application of post emergent herbicide treatment**

Use ground application equipment to apply herbicide to work areas at the appropriate labeled rate to control emerged annual and perennial vegetation.

Work areas are upland areas, but due to the proximity to wetlands and streams, all herbicides and nonionic surfactants shall be formulations approved for use in aquatic and terrestrial environments.

Acceptable herbicides include Roundup Custom (53.8% glyphosate) or other glyphosate-based product labeled for use in aquatic and terrestrial environments, as agreed upon by both contractor and Field Service Specialist. Please specify the herbicide product that you intend to use in your proposal.

Acceptable herbicide application rates may be 2 quarts/acre, 2.5 quarts/acre, or 3 quarts/acre. Please specify the application rate in your proposal.

Nonionic surfactant compatible with use in aquatic environments will be added per label instructions. Please specify the surfactant that you intend to use in your proposal.

Treatment shall be applied by UTV or other vehicle with tank and boom sprayer with (preferably flat) nozzles capable of controlled application of herbicide. Equipment shall not exceed the 10-ton weight limit of the trail/access road. Please specify the equipment that you intend to use in your proposal.

4. **CONTAINER DISPOSAL** - The contractor is responsible for the proper disposal of all herbicide and adjuvant containers as specified on the product label.

**INSURANCE AND LICENSE REQUIREMENTS:**

The contractor shall purchase and maintain at its expense the following types of insurance, issued by companies acceptable to the Commonwealth.

Prior to the commencement of work under this contract, contractor must provide the Commonwealth with current Certificates of Insurance. These certificates shall contain a provision that coverages afforded under the policy shall not be canceled or changed until at least thirty (30) days prior written notice has been given to the Commonwealth.



These certificates may include: Workman's Compensation Insurance, Comprehensive General Liability Insurance, Automotive Liability Insurance, Environmental Impairment Liability Insurance, and Subcontractors/Leased Equipment Liability Insurance.
